

## Highlights 6M25

## 6M25 Financial Highlights

- 6M25 sales have reached IDR 1,326.3b, reflecting a 2.9% YoY decrease, due to uncertainties in both global and domestic market conditions affecting buying power in 2Q25.
- Gross profit margin rose from 28.9% to 29.7% and EBIT margin increased from 11.0% to 11.4% YoY.
- FY24 net profit reached IDR 120.8b, showing a 3.8% decrease in YoY, mainly due to decrease in sales and increased G&A expenses due to professional fees and multiple events expenses.





## 6M25 Operational Highlights

- Sales of local sanitary wares decreased by 3.1% YoY, and sales of local fittings dropped by 5.6% YoY. Meanwhile, imported products (sanitary wares and fitting) still showed growth, with increase of 7.3% and 8.7% YoY, respectively
- For customer segments, sales to projects grew by 4.2% YoY, while sales to dealers decline by 6.3% YoY and sales to distributor decreased by 5.0% YoY.
